SUBJECT: **Curing Childhood Cancer, Tag Types CA & CB (prestige)**  
**National Wild Turkey Federation, Tag Types WT & WS (prestige)**  
**Barber Vintage Motorsports, Tag Types BM & BN (prestige)**  
**Save the Saturn V, Tag Types SW & SX (prestige)**  
**Race Plates, Tag Types GN (20-39) & GR (20 – 39) (prestige)**

The above referenced organizations have met their minimum number of applications required for production of their plates. The Department of Revenue has informed my office that shipments of the new plates should arrive in your county during the next few months and will be available to the general public.

Fifty dollars (\$50) credit should be applied toward the additional annual fee at the time a prepaid applicant is issued their first plate.

After plates become available, the \$50.00 additional annual fee collected should be distributed and reported on the monthly summary statement FRMS 5-A as follows:
