STAARS Track 3 Agencies:

STAARS project represents a major step forward for the State. This large multi-track project is moving forward on time and on budget. System upgrade allows the State to modernize and implement state of the art business processes. Improved business processes include electronic transactions, documents, approvals and funds transfer automated clearing house (EFT/ACH) payments.

STAARS Track 3 implementation will begin by October 1, 2015 with a Go-Live date of October 1, 2016. Track 3 agency pricing for FY 16, 17, 18 is detailed on the attached PDF. Agencies can pay all or part from FY 14 or 15 funds. Executive Budget Office understands agencies paying in FY 14 may need to revise their Operations Plans. FY 14 or 15 payments should be coordinated in advance with Finance State Business Systems. You should contact either T. J. Nola, Thomas.Nola@finance.alabama.gov (353-8145) or Margie Abernathy (Margie.Abernathy@isd.alabama.gov (353-5419)). Agency expenditures will be charged to Professional Services object 0800. Individual agency pricing will be detailed in a multi-year Interagency Service Agreement with Finance State Business Systems.

Track 3 agencies will be able to implement and use all licensed modules and capabilities to meet agency mission, goals and objectives. Attached Power Point presentation details all components in scope and implementation timelines.
