RE: Whitetail Warrior Project, Inc. (WW/WW02)
ACT 2013-251 (Change in Coding, Effective 08/01/2013)

On July 25, 2013, the Alabama Department of Revenue issued a memorandum which included information on the Whitetail Warrior Project license plate. The \$50.00 additional annual fee collected for this new license plate category should be distributed and reported on the monthly summary statement FRMS 5-A as follows:

ACT 2013-251

During the 2013 Regular Session of the Alabama Legislature, a bill was passed and enacted into law that changed the distribution of the \$5.00 portion of the \$50.00 additional license plate fee from the Penny Trust Fund to the Department of Senior Services. The location/line number on the summary statement will remain the same (line 85); however, the coding on this line has changed. This change is effective August 1, 2013; therefore, it is very important the newly revised summary statement be used when making your August tag sales remittance during the month of September. Please be sure to use the current FRMS 5-A (Rev 07-13) for your July tag sales remittance submitted to us in August.
