

RE: Act 2017-400 – Distinguished Flying Cross
Home Builders Association of Alabama

During the 2017 legislative session, Act 2017-400 established a new distinctive military license plate category for Distinguished Flying Cross recipients, as referenced in the Memorandum from the Department of Revenue on November 21, 2017. Tag type and availability will be provided by the Department of Revenue. After the plate becomes available, the \$25.00 additional annual fee collected for this new license plate category should be distributed and reported on the monthly summary statement FRMS 5-A as follows:

Distinguished Flying Cross

\$25.00	- \$ 0.63	County Commission	(2 ½ %)
	<u>- \$ 3.00</u>	Department of Corrections	(line 107)
	\$21.37	Veterans' Assistance Fund	(line 116)

The following organization has met the minimum number of applications required for production of their license plates. Tag type and availability will be provided by the Department of Revenue. After the plate becomes available, the \$50.00 additional annual fee collected for this new license plate category should be distributed and reported on the monthly summary statement FRMS 5-A as follows:
