RE:

Act 2017-379

During the 2017 legislative session, Act 2017-379 was enacted into law to amend Section 33-5-11, Code of Alabama, 1975. Effective January 1, 2018, the owner of a vessel may purchase distinctive vessel identification stickers for the additional cost of \$50.00, plus an additional issuance fee of \$2.00. Eligibility of participating organizations, colleges, and universities, along with sticker availability, will be provided by the Alabama Law Enforcement Agency. Please see the following information showing how the additional fees for the newly available distinctive vessel sticker categories should be distributed and reported on the monthly Summary Statement FRMS 5-B.
