Changes to FRMS 5-A Summary Statement

Changes to FRMS 5-A Summary Statement

Please be advised the layout of the FRMS 5-A (Rev 05-14) has also been updated to provide additional space for future new tag categories. The changes are as follows:

- 1. Line numbers 71 through 90 have shifted down and been changed to 74 through 90.
- 2. Combined line sections 78, 79, 86 (a) and 81, 84 (b) have been consolidated to only lines 81 (a) and 83 (b) respectively.
 - a. Collections for Department of Corrections Disabled Veterans, Letter Carrier, Active Marine (line 78), Mfg. Cost \$3.00 (line 79), and Dept. of Corrections \$1.50 (line 86) should now all be combined and shown on line 81 (a).
 - b. Collections for the General Fund FOP \$10.00, Law Enforcement Memorial (line 81) and Alabama Defense (line 84) should now all be combined and shown on line 83 (b).

Attached is a revised form FRMS 5-A (Rev 12-14), which includes the changes mentioned above. This form should first be used when making your December tag sales remittance to us in January. Please duplicate the revised form as needed, and <u>destroy all previous versions</u>. For your convenience, we added the revised form to our website at http://comptroller.alabama.gov. Go to the link "Procedures" and then select "County Information" from the drop down box. You may enter your information directly into the online form and print it for mailing.
