**SUBJECT:** Act 2019-138 Alabama Realtors Foundation  
 Act 2019-418 Emergency Medical Services Provider  
 Act 2019-446 Mandatory Liability Insurance Reinstatement Fee  
 Temporary Tag Fee

During the 2019 legislative session, Act 2019-138 was enacted to redirect the distribution of proceeds of sales of Alabama Association of Realtors distinctive license plates from the Alabama Children’s Trust Fund to the Alabama Realtors Foundation. The \$50.00 additional annual fee collected for this license plate category should be distributed and reported on the monthly summary statement FRMS 5-A as follows:

During the 2019 legislative session, Act 2019-418 established a new distinctive license plate category for Emergency Medical Service Providers. Tag type and availability will be provided by the Department of Revenue. After the plate becomes available, the 50.00 additional annual fee collected for this new license plate category should be distributed and reported on the monthly summary statement FRMS 5-A as follows:

During the 2019 legislative session, Act 2019-446 established new guidelines for Mandatory Liability Insurance Reinstatement. Effective reporting period beginning December 1, 2019, the Mandatory Liability Insurance Reinstatement fees should be distributed and reported on the monthly summary statement FRMS 5-A as follows:

**Mandatory Liability Insurance Reinstatement – First Offense**

<b>\$200</b>	- \$ 30.00	Retained by the County	(15 %)
	\$ 144.50	Department of Revenue 85%	(line 118)
	\$ 25.50	Alabama POA&B Fund 15%	(line 119)

**Mandatory Liability Insurance Reinstatement – Second or Subsequent Offense**

<b>\$400</b>	- \$ 60.00	Retained by the County	(15 %)
	\$ 289.00	Department of Revenue 85%	(line 118)
	\$ 51.00	Alabama POA&B Fund 15%	(line 119)

Effective reporting period beginning December 1, 2019, the fee from issuance of each Temporary Tag should be distributed and reported on the monthly summary statement FRMS 5-A as follows:

**Temporary Tags**

<b>\$2.50</b>	- \$ 0.75	Retained by the County	
	- \$ 1.25	Public Road and Bridge Fund	(line 120)
