 Changes to FRMS 5-A Summary Statement

The following organization has met the minimum number of applications required for production of their license plates. Tag type and availability will be provided by the Department of Revenue. After the plate becomes available, the \$50.00 additional annual fee collected for this new license plate category should be distributed and reported on the monthly summary statement FRMS 5-A as follows:

Act 2021-432

During the 2021 legislative session, Act 2021-432 amended Code Section 32-6-271 relating to distinctive Fire Fighter license plate categories. Effective January 1st, 2022, the additional annual fee collected for this license plate category will increase to \$1.00. Half of the net proceeds due to the Alabama Joint Fire Council shall be used for the purpose of expanding and maintaining the Alabama Firefighter Memorial and half of the net proceeds shall be

used for expenses associated with the Firefighter Peer Support Program. Beginning February 1st, 2022, this \$1.00 additional annual fee should be distributed and reported on the monthly summary statement FRMS 5-A as follows:
