SUBJECT: Alabama Golf Association
 Discontinued License Plate Categories

The following organization has met the minimum number of applications required for production of their license plate. Tag type and availability will be provided by the Department of Revenue. After the plate becomes available, the \$50.00 additional annual fee collected for the new license plate category should be distributed and reported on the monthly summary statement FRMS 5-A as follows:
