SUBJECT: State Police Retirement Legislation – Senate Bill 68

In the 2023 Legislative Session, Senate Bill 68, was enacted as Act 2023-73 regarding employee retirement contributions for state policemen working for the Alabama State Law Enforcement Agency who are certified by the Alabama Peace Officers' Standards and Training Commission and perform law enforcement duties required the following changes in Payroll effective the pay period beginning August 01, 2023.

- Law Enforcement retirement deduction codes for employees affected by the legislation and in active pay status on 8/1/2023 have been changed to the State Police retirement codes on the PENS screen effective 8/01/2023.
- Law Enforcement overtime retirement deduction codes for the employee and employer shares of overtime retirement for employees affected by the legislation and in active pay status on 8/1/2023 have been changed to the State Police retirement codes on the MISC screen with effective date of 8/01/2023.
- Agency payroll staff are responsible for creating PENS screen retirement deduction entries for all new state policeman employees subject to State Police retirement who are hired after 8/01/2023.
