**SUBJECT:** 2026 Payroll Deduction Limits for Pre-tax Deferrals and Roth Plans

The pre-tax deferral and Roth limits have increased for the 2026 calendar year. The chart below outlines these changes. Employees ages 50–59 and those over age 63 with deferred compensation or Roth plan deductions should be set up with the Age 50+ catch-up deduction codes. Employees ages 60–63 should be set up with the Age 60–63 super catch-up deductions. This change is effective for the January 16, 2026, paycheck. The “Employees with Deferred Comp Age 50 Plus Report” and “Employees with Deferred Comp Age 60-63 Report” will assist you in determining which employees should be updated and are available in the Prelim App and InfoAdvantage.
